

Sealed quotations are hereby invited on behalf of Principal, Kendriya PM SHRI KENDRIYA VIDYALAYA NO-4 BHUBANESWAR, from the reputed Registered travel company/firms for hiring of vehicles on as and when required basis. Interested agencies should quote their rate typed (hand written quotation not allowed) on their official letter in the format supplied with this document only. Bids received in other format will not be considered. (The quoted rate should be inclusive of all the taxes and no other charge shall be mentioned).

Terms and conditions on which contract will be executed:

- 1. Agency should be registered with concerned department to provide Vehicle on hiring.
- 2. Mileage and time will be counted from the time of reporting and from office to office.
- 3. Toll Tax, Parking Charges etc. will be inclusive in the rates quoted by the firm/agency.
- 4. Payment will be made on monthly basis by PFMS/RTGS/NEFT on getting bill along with duty slip certificate by the officer/ teacher of this office who has used the vehicle.
- 5. Vehicle should be provided at short notice. Cleanness of vehicle and its condition should be excellent. If the vehicle is not in excellent condition, the contract is liable to be rejected.
- 6. The person/ persons whose quotations is submitted/ accepted, herein after called the contractor. On acceptance of the quotation, it will become a contract and the contractor shall be bound by the terms and conditions of the quotation. After successful bidding process, when order will placed for vehicle; the qualified bidder has to submit a copy of registration certificate and fitness certificate of the vehicle before proceeding for destination.
- 7. The driver with clean police record should be in neat & clean dress, well behaved, non alcoholic/while on tour.
- 8. Vehicles so requisitioned should report in time.

- 9. Penalty etc. if imposed by Traffic Police/Department will not be paid by this office.
- 10. If the agency fails to provide the vehicles so requisitioned, in time after receiving the message, the contract is likely to be cancelled without assigning any reason.
- 11. EMD will be retained as Performance Security for only that firm/agency which is awarded the contract.
- 12. The quoted rate must be <u>valid for one year</u> and may be extendable on yearly basis based on the performance.
- 13. The last date for submitting the complete tender document is 17-12-2023 up to 3.00 PM. The quotations received will be opened on 18-12-2023 at 4:00 PM at Office of the Principal, Kendriya PM SHRI KENDRIYA VIDYALAYA NO-4 BHUBANESWAR. - 3. A demand draft of `5,000/- (Rupee Five Thousand Only) in favour of 'VVN Account KENDRIYA VIDYALAYA NO-4 BHUBANESWAR as Earnest Money Deposit be submitted by the firm. The tenders not accompanied by the EMD amount will be summarily rejected, but the SSI (MSME) Unit, registered with The National Small Scale Industries Corporation Ltd. (NSIC) under Single PointRegistration Scheme and holding a valid Registration certificate with NSIC, are exempted from payment of 'Earnest Money Deposit'.
